



MEMORANDUM CIRCULAR WSHGQ 2-2022

TO : Members of the Board of Directors, PPSA Area Coordinators, NROI Area Coordinators, Gun Club Presidents, and PPSA Members.

SUBJECT : Revised and Updated Guidelines for the Selection of the Philippines Team Members vying for slots for the Handgun World Shoot XIX 2022 in Pattaya, Thailand.

DATE : March 12, 2022

I. OBJECTIVE

The objective is to develop the skills of shooters nationwide through participation in Level III Matches, Special Qualifier Matches or higher matches with courses of fire designed and constructed to test shooters skills in a competitive environment ensuring a World Class Standing and podium finish.

To qualify, aspirants will need to meet percentile requirements that will be based on the results of the Qualifier matches.

II. ASPIRANTS QUALIFICATION CRITERIA FOR HANDGUN WORLD SHOOT XIX, 2022 PATTAYA, THAILAND

DIVISIONS* = BEST 10 PERCENTILE SCORES TO COUNT EXCEPT PRODUCTION OPTICS LIGHT WHICH SHALL BE BEST 6 PERCENTILE SCORES

CATEGORIES** = BEST 6 PERCENTILE SCORES TO COUNT

*TO QUALIFY FOR HANDGUN WORLD SHOOT XIX 2022, DIVISION SLOTS/TEAM, ASPIRANTS MUST HAVE SHOT AUSTRALASIA 2019 AND AT LEAST 1 QUALIFIER AND/OR CONFIRMATION MATCH IN 2022.

THE ASPIRANT'S AUSTRALASIA SCORES WILL BE COUNTED AS TWO MATCHES. (THE PPSA MAY SEGREGATE THE PHILIPPINE REGION'S AUSTRALASIA SCORES FOR QUALIFIER TABULATION PURPOSES).

****WORLD SHOOT XIX 2022 TEAM/CATEGORY ASPIRANTS MUST SHOOT ONE (1) QUALIFIER MATCH BEFORE AUGUST 1, 2022.**

III. TENTATIVE / PROPOSED MATCHES

All Qualifier Matches will be posted on the PPSA Official Social Network Page, PPSA/PSMOC Shooters Page, and PPSA Official website. In the event that there is a shortage of Qualifier Matches, the Match Committee may declare other Level III matches as Wild Card Matches which will be declared via transparent raffle.

A. WORLD SHOOT XIX, Handgun 2022 Division Teams and Slot Allocation

For Division Teams, the total of the **best (10) match scores (percentile)** of each aspirant in the 2018-2022 Qualifier Matches will be the basis for Division Team selection.

FOR PRODUCTION OPTICS AND PRODUCTION OPTICS LIGHT, THE FOLLOWING SHALL BE THE CRITERIA.

PRODUCTION OPTICS - The total of the **best (10) match scores (percentile)** of each aspirant in the 2018-2022 Qualifier Matches will be the basis for Division Team selection.



In case of a tie, the highest percentile out of the 10 will be used as a basis to break the tie. In case this will still result in a tie, the highest percentile out of the remaining Qualifier Matches will be used.

PRODUCTION OPTICS LIGHT - The total of the **best (6) match scores (percentile)** of each aspirant in the 2018-2022 Qualifier Matches will be the basis for Division Team selection.

In case of a tie, the highest percentile out of the 6 will be used as a basis to break the tie. In case this will still result in a tie, the highest percentile out of the remaining Qualifier Matches will be used.

FOR CATEGORIES - The total of the **best (6) match scores (percentile)** of each aspirant will be the basis for Category Slot Allocation for Teams and individuals.

In case of a tie, the highest percentile out of the 6 will be used as a basis to break the tie. In case this will still result in a tie, the highest percentile out of the remaining Qualifier Matches will be used.

After every qualifier match, the ranking of each aspirant will be posted in the PPSA Official Social Network Page, PPSA/PSMOC Shooters Page, and PPSA Official website.

It is the aspirants' responsibility to verify that the entries of his/her scores are correct and to advise the PPSA Office of any discrepancies.

The PPSA reserves the right to lessen the number of match scores/percentiles to be counted in case some Qualifier Matches will be cancelled due to non-compliance of the criteria/requirements/Terms & Conditions set forth by the Match Committee or due to weather, peace and order, political, regulatory, or other major issues and pandemic protocols, beyond the control of PPSA.

FULL SPONSORSHIP PACKAGE – THE PPSA WILL FULLY SPONSOR THE IPSC DIVISION TEAMS FOR WORLD SHOOT.

IN THE UNLIKELY EVENT THAT NO REGIONAL TEAMS WILL BE REGISTERED BY OTHER IPSC REGIONS – ONLY INDIVIDUAL REGISTRATION FEES WILL BE PAID FOR BY THE PPSA.

The PPSA Sponsorship package shall only include;

- a. Airfare to and from Manila – Bangkok – Manila based on best available price.
- b. Hotel accommodations commencing from November 23, 2022 to December 4, 2022 based on best available price and twin sharing.
- c. Transportation from Bangkok airport to Pattaya delegation hotel and back to airport.
- d. Land transportation from hotel to range and back to-be-announced.
- e. Food allowance to-be-announced, from November 23, 2022 to December 3, 2022.
- f. Team and individual registration fees.
- g. Team uniform

In case the Royal Thai Government/Tourism Authority of Thailand shall require other COVID-19 related requirements, all expenses related therein shall be shouldered by the shooter.

*****THE PPSA RESERVES THE RIGHT TO INCREASE OR REDUCE THE AVAILABLE CATEGORY SLOTS SUBJECT TO FINAL SLOT ALLOCATION BY IPSC. SINCE SLOTS SHALL BE VERY LIMITED, THE PPSA LIKEWISE RESERVES THE RIGHT TO ASSIGN SHOOTERS TO THE PRE-MATCH.**

*****THE PPSA ALSO RESERVES THE RIGHT TO CHOOSE WHICH DIVISION/CATEGORY TEAMS TO FIELD.**


C. WORLD SHOOT XIX HANDGUN 2022

We have been informed by IPSC that slots for WORLD SHOOT XIX Handgun 2022 will be very limited. The actual number of slots may vary depending upon the actual number of slots to be given by IPSC.

To qualify for the slot. WORLD SHOOT XIX Handgun 2022 Category Shooters should have the following percentiles in six (6) Qualifier/Wild Card Matches up to the last match in 2022.

PPSA will sponsor the Category registration fee if the aspirant's qualifier average reaches the minimum percentile (%) stipulated in this memorandum for WORLD SHOOT XIX Handgun 2022 AGAIN SUBJECT TO SLOT AVAILABILITY.

IV. DURATION OF QUALIFIER MATCHES & SANCTIONING POLICIES

All World Shoot XIX Handgun 2022 Qualifier matches will be announced and posted in the PPSA Official Social Network Page, PPSA/PSMOC Shooters Page, and PPSA Official website.

V. ASPIRANTS APPLICATION FORM REQUIRED FOR SCORE TABULATION

Aspirants should fill up an application form and affix their signatures as their conformity with the terms and conditions and send the signed form to the PPSA office or through email at a.ppsa@yahoo.com.ph for their scores to be tabulated.

The Aspirants Application Form for World Shoot XIX Handgun 2022 can be downloaded from the PPSA website.

Aspirants forms should be signed and submitted on or before April 30, 2022. Only renewed members for 2022 shall be accepted.

Names as appearing in their passports should be used in the Aspirants Application form and the match registration.

VI. QUALIFIER MATCHES FOR 2022

The PPSA reserves the right to squad the aspirants in their respective Divisions/ Category in all the 2022 Qualifier matches.

Scores will not be counted in the computation of the shooters ranking if aspirants fail to shoot in their designated squads.

VII. SHIPMENT OF FIREARMS AND AMMUNITION

All Philippine delegates are responsible for bringing their own firearms and ammunition to World Shoot XIX Handgun 2022.

Shooters shall submit the following and should take note that;

- a. Photocopy of passport which should be valid for six months prior to departure.
- b. LTOPF should be valid until December 31, 2022
- c. FA Registration should be likewise valid until December 31, 2022
- d. Photocopy of confirmed flight details

Delegates may also consider using the Official Match Ammunition (OMA).

VIII. ADDITIONAL REQUIREMENTS & CONDITIONS



All aspirants should shoot in their assigned squads in the main match of the remaining Qualifier Matches. Scores in the pre-match will not be accepted and will not be included in the computation of the rankings except for Australasia 2019.

Aspirants/Team members should possess all travel documents as required by law including IATF Protocol documents.

Aspirants should refer to www.tatnews.org for all requirements for entry into Thailand.

Team members are required to attend the Opening Ceremony (Parade) and Awarding Ceremony of WORLD SHOOT XIX HANDGUN 2022 wearing the prescribed uniform or attire. They shall likewise be required to wear the official team uniform during the duration of the match.


IX. PPSA SPONSORSHIP AGREEMENT/REVOCATION

All shooters shall sign a PPSA Sponsorship Agreement specifying all the terms and conditions within ten (10) days from official announcement of the sponsored team members.

The PPSA reserves the right to modify the terms and conditions of this circular as it deems necessary.
